**COURT ORDER AND ENTRY GRANTING IN PART
DEFENDANTS' MOTION FOR GAG ORDER**

Pursuant to the evidentiary hearing held on May 9, 2025, regarding Defendants', The Adamo Group, Inc., et al and SCM, joint motion for Gag Order, all parties were given an opportunity to proffer an order addressing the issue at hand. Defendants, the Adamo Group, Inc., et al, SCM and BWC, as well as Plaintiffs, all submitted proposed Court Orders. The Court thanks the parties for their diligent efforts.

It is hereby the Order of this Court that all parties to the captioned litigation, including Alissa Miller, acting as an individual or in her capacity as durable power of attorney/legal agent of Plaintiff, Travis Miller, are subject to the following limitations and restrictions, and said limitations and restrictions apply to any means of public communications authored, tagged, distributed, posted or otherwise published, and IT IS SO ORDERED:

1. **Scope.** This gag order (hereinafter "Gag Order: or "Order) shall apply to all media platforms, including but not limited to, Facebook, TikTok, Instagram, X, Snapchat, or other

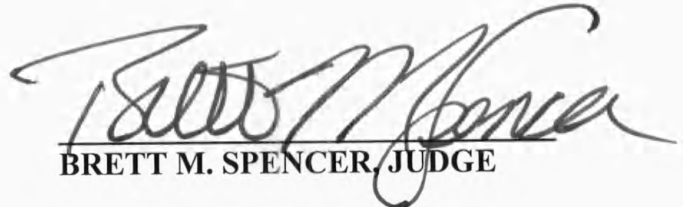
social media and new-based platforms.

2. **Purpose.** The purpose of this Gag Order is to protect against and avoid any further dissemination of information that may be untrue, misleading, false, confidential, private, non-public information which may interfere with a fair trial. This Order does not limit the expression of any personal opinion so long as the opinion is not based on false, confidential, or otherwise protective information violative of this Order. Ignorance as to whether a statement is false or untrue does not alleviate the obligation to refrain from publishing the information.
3. **Directive.** No party shall post, publish, share, or otherwise communicate false, untrue, protected or confidential information concerning (1) statements made in private court hearings that are subject to confidentiality and protective order entered by this Court; (2) deposition testimony and exhibits that are subject to confidentiality and protective order entered by this Court; (3) motions, hearing, or other pending court decisions that are subject to confidentiality and protective order entered by this Court; (4) any evidence not a matter of public record on the docket for this matter, Adams County Consolidated Case No. CVC 20210422 that are subject to confidentiality and protective order entered by this Court; (5) confidential statements or protected information learned through discovery in this litigation that are subject to confidentiality and protective order entered by this Court; (6) information related to mediation or settlement conference or related in any way to settlement discussions that are subject to confidentiality and protective order entered by this Court; (7) extrajudicial statements that are subject to confidentiality and protective order entered by this Court; and (8) any other non-public information likely to prejudice any party that are subject to confidentiality and protective order entered by this Court.

4. **Duration.** This Order shall remain in effect throughout the pendency of this litigation as well as any appeal(s).
5. **Modification.** This Order shall only be subject to modification by the Court on its own motion or on motion of a Party.
